- 1. Principal/Director's Evaluation Florida School Leader Assessment
  - a. It was decided to use the procedures sent by the State of Florida to do our Principal/Director's Evaluation.
  - b. The Principal/Director's Evaluation Procedures will appear as an Action Items on the April 11, 2012 FAUS SAB Meeting.
- 2. Survey and Assessment
  - a. A discussion was held on how to best go about getting parent input for the Principal/Director's Evaluation.
    - i. Should there be one survey for everything?
    - ii. Ideal size would be 20 questions.
    - **iii.** Questions should be condensed, i.e. "I feel that the school is clean," rather than 5 different questions on different areas of the school.
  - b. We should tie the Principal/Director appraisal into the SAB appraisal.
  - c. Discussion was held on whether there should be separate surveys for K-9 and 10-12.
    - i. It was decided that these two surveys should definitely be separate.
  - d. Discussion was held as to whether it should be one survey per child or one survey per household.
  - e. The 2010-2011 Parent Survey was reviewed for questions which would be feasible to use on the 2011-2012 Parent Survey.
- 3. Principal/Director Evaluation Standards were put on the overhead projector for review by the committee members, and specific questions were discussed.
