I. Review of Committee Minutes

The Committee reviewed the Education Committee minutes from February 24, 2010.

- II. Race To The Top
 - a. Mr. Glenn Thomas gave an update on Race To The Top (RTTT).
 - i. We expect to hear if Florida has been accepted in mid-April.
 - b. Effect of Senate Bill 6:
 - i. There will be issues on merit pay.
 - ii. There will a profound effect on the way students are assessed.
 - iii. Senate Bill 4 did pass. It will affect FCAT for high school students.
 - iv. Teachers would be granted a series of annual contracts over a 5-year period. There would be no tenure.
 - v. Bill passage will exacerbate the state's teacher shortage.
 - vi. Mr. Thomas will create a page for the next School Advisory Body meeting which will be a composite of the Bill.
- III. School Improvement Plan Health and Wellness
 - a. Ms. Barkes distributed "Action Plan, Goal V (Aligned to State Goal 4).
 - b. The ADHUS kitchen could be utilized as a "learning lab."
 - i. Students are growing a vegetable garden and sunflower garden.
 - c. Ms. Barkes distributed "FAIR Summary, 1st and 2nd Quarter Data Comparison."
 - i. FAIR is an online reading assessment for approximately 2 million Florida students.

IV. Policy on Disputes

- a. All procedures and different levels regarding handling of Disputes are given in Policy 5.35 of the School Board Policy Manual.
- b. "The FAUS Advisory Body has the responsibility to periodically monitor the dispute resolution process and approve amendments to this policy; however, the Board shall at no time be a party to the resolution of or conversation related to any specific parent or legal guardian dispute."
- c. Mr. Glenn Thomas will send a Dispute template to the SAB.
- d. A parent who attended the meeting was allowed to ask a question on the Dispute Policy and was told that the SAB is an advisory body only; the administration has direct responsibilities; and the FAU Board of Trustees is the ultimate policy approval and oversight governing body.
- e. Mr. Glenn Thomas informed the attending parents that if they had any major concerns on disputes, they could contact Dr. Hodge, Mr. Thomas, or Dean Bristor, as provided in the Dispute Resolution Policy. They were also instructed to communicate with SAB parent representatives to bring their concerns before the Advisory Body.
- f. Mr. Thomas spoke on the student Discipline Code steps:
 - i. The school responds immediately.
 - ii. The SAB approved Code of Student Conduct provides general sets of consequences for student infractions.
 - iii. Individual students' information including specific disciplinary actions, are protected by state and federal confidentiality laws and regulations.
- g. Dr. Patricia Hodge further explained the procedures for the school contact with parents/guardians of injured children and for children being disciplined.
