- A. Code of Student Conduct, 2012-2013
 - 1. Dr. Ferguson stated that she did not intend to replace the RTR position for the 2012-2013 school year. Mrs. Williams, who filled this position and was employed by ADHUS for approximately 16 years, retired on June 7, 2012. Student issues will be handled first by the teacher and then, if necessary, with the assistance of an administrator.
