- C. Parking for Parents: Dr. Ferguson had a meeting today with the FAU Traffic Department. It would cost approximately \$1.3 million to change the current traffic patterns. Dr. Ferguson will furnish some hang tags, available through the Front Office, so that parents do not get ticketed. This is being done in combination with Slattery.
- D. Middle School Trip: Mrs. Daphne Smolka stated that a Middle School trip this year to the Grand Canyon will cost \$1,780 per student. Dr. Ferguson stated that this is a supplemental trip to the annual class trips. Chaperones generally travel free, based on the number of students attending. Mr. Feit stated that the school receives tremendous feedback about the educational experience that is shared from these trips.
