- A. Budget Review
 - 1. Mr. Troy McLellan reviewed the activity and supplemental budget in detail explaining there was a \$50,000 increase from fiscal year 2011-2012 for the supplemental budget.
 - 2. A finalized budget will be available at the September 12, 2012 Advisory Body Meeting.
- B. Parent Representatives, 2012-2013
 - Currently, there are two at-large representatives' positions still available.
- C. Activity Fees Protocol
 - 1. Dr. Collum gave a brief history on the collection of the activities fees collection process.
 - 2. On April 4th there was an outstanding balance of \$84,000. Currently, the balance has decreased to \$14,987 since follow up on previous payments has commenced. There are a total of five families who have received the third and final notice for lack of payment

- from previous fiscal years. These families will be referred to the Dean of the College of Education, Dr. Valerie Bristor, for student withdrawal recommendation.
- 3. The Free and Reduced Lunch Applications are reviewed and approved by the Florida Department of Agriculture. Results have not yet been released. The activity fee collection has been extended to the first day of school due to this information. If a family qualifies for the free and reduced pricing in the previous years they will have a 30 day window until qualification for this year is received.
