Approval of the March 24, 2010 FAUS Committee Meetings Amended Minutes a.

Motion – Motion was made by Mr. Marc Hopins to approve the March 24, 2010 1. FAUS Committee Meetings Amended Minutes with the following additional changes: (1) Education Committee, Section III.b. - Change from "The ADHUS kitchen has a "learning lab" to "The ADHUS kitchen could be utilized as a "learning lab." (2) Finance Committee, Section II.c. - change to read "Because not all students pay an activity fee, an additional \$35,000 needs to be paid by students who pay an activity fee."

b. Activity Fee

- 1. Mr. Glenn Thomas stated that the current activity fee will remain in place until a recommendation is made to the Board of Trustees by the School Advisory Body, and changes are then made by the Board of Trustees. Any changes need to be in the hands of the Board of Trustees no later than 5:00pm on May 14, 2010.
- 2. Mr. Glenn Thomas stated that he had received no response from legal counsel regarding a review of our current Activity Fee structure.

Motion – Motion was made by Dr. Deborah Shepherd to retain the current Activity Fee structure, and those parents with financial difficulties could speak with Administration regarding reduced and free options.

Second – Seconded by Ms. Robin Barkes

Discussion:

Discussion and questions regarding this Motion included:

- Ms. Kris Moser: Does the state of Florida contribute to the free and reduced lunch program;
- Dr. Deborah Shepherd: Is there an option to "opt out" of specific items on the Supplements list, such as the yearbook, PE uniforms, etc.;
- Ms. Tracie Nieporte: Would legal counsel be able to respond to Mr. Thomas and the SAB, prior to the May 14th deadline;
- Mr. Marc Hopin: Regarding questions on the legality of the activity fee, does the activity fee violate a Florida statute; both Mr. Thomas and Dr. Hodge responded "no."
- Dr. Stephen Locke: Stated that if we tried to impose an activity fee on those who qualify for free and reduced programs, we might be violating a Florida statute.
- Mr. Glenn Thomas: Distributed and discussed "Florida Atlantic University Report of Budget for Auxiliaries as of 05/11/2010."
- Mr. Marc Hopin: He has consulted with a private attorney who has advised that the activity fee is in violation of Florida statute; he wants it on record that he made a request that the SAB speak with his counsel, prior to this evening's vote, but that this was not done.
- Mr. Marc Hopin: Asked if there was any carry-over which would reduce next year's activity fee. Mr. Thomas responded that Accounts Receivables are being collected right now, which affects disbursement.
- Mr. Marc Hopin: Suggested and discussed a new activity fee structure, as follows:
 - Elementary School = \$325.00; Middle School = \$500.00; High School = \$540.00.

Proposed Amendment to Motion – Ms. Tracie Nieporte proposed an amendment to the Motion made by Dr. Deborah Shepherd, accepting the change in activity fees for the three grade levels, as suggested above by Mr. Hopin.

Proposed Amendment Rejected: Dr. Deborah Shepherd rejected Ms. Tracie Nieporte's Proposed Amendment to Motion.

Proposed Amendment to Motion is denied.

Vote taken on Dr. Deborah Shepherd's original Motion to retain the current Activity Fee structure, and those parents with financial difficulties could speak with Administration regarding reduced and free options.
